The board asked that Maria to call or email all current 4° & 5° gr. parents who have not registered for next year to have them offer their intentions and registration & deposit so that we know the exact # of Gr.5 & 6 students committed in returning. If we have the majority of the current 4° graders and at least six of the 5° graders returning, the board would consider hiring the additional half-time teacher. Angie motioned, Karla 2° approval to proceed on the possibility of hiring a half-time teacher by having Maria follow-up with 4° & 5° gr. parents to receive final commitments.
