Scholarship Fund Sources

Due Dates: In order to be considered for the **first two scholarships above**, applications **must be received by April 15, 2020**, and additional forms may be required. These two scholarships have income criteria that are very similar to the income level requirements for the free and reduced lunch program income level. Scholarship applications for the **remaining funds** are **due April 30, 2020**. The income level criteria for the last two scholarship funds are at a higher level than the others. Funds are limited so applications that are returned after the due date will only be considered if funds are still available. Due dates for these different scholarship sources vary so final allocation of scholarships may not occur until summer. Families will receive an initial letter about their scholarship status by the first week of June. Final scholarship amounts could be adjusted as the process is completed by the various donors. The adjusted amount for the total scholarship given will not be less than the amount stated in this first letter, however it may be adjusted as to which source the scholarship is coming from. Please wait to acknowledge the donors with a thank you until you receive your final scholarship letter during the summer. Thank you's are important in encouraging continuation of scholarship donation to the school program.

Tuition Scholarship Request:

Keep in mind that the entire amount of tuition will not be granted for a scholarship. There must be a mixture between the portion paid by the family and the portion requested as a scholarship. Tuition for the 2020-2021 school year is \$2,250 per student with a cap of \$5,865 per family for the K-6 program. Preschool tuition for next year is \$130 a month for 2 days per wk and \$190 a month for 3 days per wk, \$230 for the new full school day preschool for 2-days per wk, and \$340 for the full school day preschool for 3-days per wk.
